<p>INSTRUCTIONS TO VOTER Vote on the race or measure by placing an appropriate mark (blacken the oval <input type="radio"/>) beside the measure either FOR or AGAINST, or beside the candidate's name.</p> <p>If you vote for more than one candidate in a race, your vote in that race will not count. If you vote both FOR and AGAINST on a measure, your vote will not count in that measure. If you make a mistake on your ballot, return it to an election official for a replacement ballot. You may replace up to two ballots in an election.</p> <p>ABSENTEE VOTERS If you vote for more than one candidate in a race (overvote), your vote in that race will not count. The instructions at the top of the ballot regarding correcting an overvoted ballot direct the voter to return his/her ballot to an election official for a replacement ballot. This is often not possible for absentee voters.
