FINANCE COMMITTEE MEETING

Josh Curtis called the meeting to order. Motion made by Pat Bisbee, second by Mark Grimmett, to approve the Minutes from the Finance Committee meeting held on August 2, 2021. Vote was unanimous, motion passed.

Exhibit "B" – Appropriation Ordinance Authorizing Grant Application Process for VOCA Grant for 2021-22. Motion to approve made by J. R. Walters, second by Tammy Schmidt. Vote was unanimous, motion passed.

Exhibit "C" – Appropriation Ordinance Authorizing Grant Application Process for STOP Grant for 2021-22. Motion to approve made by J. R. Walters, second by Tammy Schmidt. Vote was unanimous, motion passed.

Action Item 1: Saline County Road Department – Moving Prior New Hire Pay, Retroactively, to \$17.50.

Action Item 2: Saline County Prosecuting Attorney – Moving Employee Pay to \$13.25 and Adding \$1.00 for Bilingual Skills.

Josh Curtis asked that both Action Items be voted on together, so after discussion of both a motion was made by J. R. Walters, second by Carlton Billingsley to approve. Vote was unanimous, both Action Items approved.

Informational Item: Overview of American Rescue Plan and Saline County RFP – Angie Drummond gave a Power Point Presentation and answered questions by the Q.C. Members. Judge Arey gave a very detailed explanation of the Review Plan that he, Angie Drummond and Will Gruber have put together and suggested that the Q.C. consider using it to ensure that the funds are appropriated according to IRS guidelines. There was some discussion among Q. C. Members. It will be discussed and voted on in the September Quorum Court meeting.

Mr. Curtis asked for Public Comment -- Ken Yang spoke about the American Rescue Plan and encouraged Q.C. Members to look into some webinars to help them understand the Plan better.

Motion to Adjourn was made by J. R. Walters, second by Tammy Schmidt. Vote was unanimous, meeting adjourned.

BE IT ENACTED BY THE QUORUM COURT OF SALINE COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: "AN ORDINANCE DELEGATING THE RESPONSIBILITY FOR THE COLLECTION OF DELINQUENT DISTRICT COURT FINES, FEES, AND COURT COSTS."

WHEREAS, the Quorum Court of Saline County recognizes the challenges of collecting district court fines, fees, restitution, and court costs under Ark. Code Ann. §16-13-701 (hereafter collectively referred to as "fines").

WHEREAS, the Quorum Court deems that additional appropriate and lawful steps are necessary to aid in the collection of Saline County District Court ("District Court") fines under Ark. Code Ann. §16-13-709.

WHEREAS, the Quorum Court is specifically authorized under Ark. Code Ann. §16-13-709 to delegate the responsibility for the collection of delinquent fines assessed in the circuit and/or district court to a private contractor, and the private contractor may collect a commission, under a written contract, from the total amount of fines owed by a defendant who is delinquent.

NOW, THEREFORE, BE IT ORDAINED by the Quorum Court of Saline County, Arkansas that:

Article 1. The Quorum Court, under its authority granted pursuant to Ark. Code Ann. § 16-13-709, hereby delegates the responsibility for the collection of delinquent fines, as defined under Ark. Code Ann. §16-13-701, assessed in the District Court.

Article 2. The Quorum Court, under its authority granted pursuant to Ark. Code Ann. § 16-13-709, hereby authorizes the Association of Arkansas Counties, a private contractor, properly registered and bonded with the Secretary of State in accordance with § 16-13-709, and its employees, agents, and subcontractors, as the entity to collect delinquent fines assessed in the District Court.

Article 3. The Quorum Court, hereby authorizes all necessary parties to ensure that a written contract is entered into to accomplish the intent of this ordinance.

Article 4. Severability: Should any word, phrase, or section of this ordinance be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity shall not affect the force and validity of the remaining portion of sections of this ordinance.

BE IT ENACTED BY THE QUORUM COURT OF SALINE COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

"AN ORDINANCE APPROPRIATING COUNTY GENERAL FUNDS FOR THE YEAR 2021."

WHEREAS, the County is eligible for an additional part-time position under the current reimbursable VOCA Grant for the Prosecuting Attorney's office for the 2021-2022 grant year beginning October 1, 2021; and,

WHEREAS, this Grant is funded by Fund 1000 – County General Fund, Prosecuting Attorney Grant/Reimbursable Salaries – Department 0451.

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF SALINE COUNTY, ARKANSAS:

<u>Article 1</u>. That the sum of \$6,665.38 is hereby appropriated in Fund 1000 – County General Fund, Prosecuting Attorney Grant/Reimbursable Salaries – Department 0451 budget as follows:
