# SALINE COUNTY QUORUM COURT MINUTES SEPTEMBER 20, 2021

The Saline County Quorum Court met on Monday, September 20, 2021 at 6:30 p.m. in Courtroom #3 in the Saline County Courthouse. Proceedings were held in person and via ZOOM. There were 9 members present. Justices of the Peace Pat Bisbee, Mark Grimmett, Tammy Schmidt and Jim Whitley participated via ZOOM. County Judge Jeff Arey called the meeting to order. Justice of the Peace Clint Chism gave the invocation and Judge Arey led the Pledge of Allegiance.

Roll call was taken with all 13 members present.

Saline County Circuit Clerk Myka Samples, County Circuit Chief Deputy Ragan Kyzer, Saline County Sheriff Rodney Wright, County Comptroller Angie Drummond, County Attorney Will Gruber, County Judge Administrative Assistant Vicki Hopkins, County Clerk Doug Curtis, and County Clerk Chief Deputy Lydia Brown were present.

Motion by J.R. Walters and seconded by Carlton Billingsley to approve the minutes from the August 17, 2021 Quorum Court Meeting. Motion passed unanimously by voice vote.

### **OLD BUSINESS:**

WHEREAS: Grayson's family, Angie and Monty Freel, and siblings Ellis and Brodie Freel, are incredibly proud and supportive of his efforts, especially since 4-H is a family tradition for the Freels; and,

WHEREAS: Grayson has been active not only in 4-H, as a member of the Saline County 4-H Teen Leaders Club and Saline County 4-H Shooting Sports Club, but as a member of the 2020-2021 7-A State Championship winning Bryant Hornets Varsity Football Team; and

WHEREAS: Grayson is a 2021 graduate of Bryant High School and is a Freshman at Henderson State University, where he is studying Recreation, and is actively involved in the college community; and,

WHEREAS: Grayson lives by the motto made famous by Donald McGannon, "leadership is an action, not a position"; and,

WHEREAS: the Saline County Quorum Court, all of the Saline County elected officials and employees, and the citizens of Saline County are very proud of the accomplishments of Grayson.

NOW, THEREFORE, I, Jeff Arey, Saline County Judge, along with the Saline County Quorum Court, do hereby recognize and heartily congratulate Grayson for the tremendous achievement of being elected State 4-H President.

BE IT ENACTED BY THE QUORUM COURT OF SALINE COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: "AN ORDINANCE DELEGATING THE RESPONSIBILITY FOR THE COLLECTION OF DELINQUENT DISTRICT COURT FINES, FEES, AND COURT COSTS."

WHEREAS, the Quorum Court of Saline County recognizes the challenges of collecting district court fines, fees, restitution, and court costs under Ark. Code Ann. §16-13-701 (hereafter collectively referred to as "fines").

WHEREAS, the Quorum Court deems that additional appropriate and lawful steps are necessary to aide in the collection of Saline County District Court ("District Court") fines under Ark. Code Ann. §16-13-709.

WHEREAS, the Quorum Court is specifically authorized under Ark. Code Ann. §16-13-709 to delegate the responsibility for the collection of delinquent fines assessed in the circuit and/or district court to a private contractor, and the private contractor may collect a commission, under a written contract, from the total amount of fines owed by a defendant who is delinquent.

NOW, THEREFORE, BE IT ORDAINED by the Quorum Court of Saline County, Arkansas that:

Article 1. The Quorum Court, under its authority granted pursuant to Ark. Code Ann. § 16-13-709, hereby delegates the responsibility for the collection of delinquent fines, as defined under Ark. Code Ann. §16-13-701, assessed in the District Court.

Article 2. The Quorum Court, under its authority granted pursuant to Ark. Code Ann. § 16-13-709, hereby authorizes the Association of Arkansas Counties, a private contractor, properly registered and bonded with the Secretary of State in accordance with § 16-13-709, and its employees, agents, and subcontractors, as the entity to collect delinquent fines assessed in the District Court.

Article 3. The Quorum Court, hereby authorizes all necessary parties to ensure that a written contract is entered into to accomplish the intent of this ordinance.

Article 4. Severability: Should any word, phrase, or section of this ordinance be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity shall not affect the force and validity of the remaining portion of sections of this ordinance.

BE IT ENACTED BY THE QUORUM COURT OF SALINE COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

"AN ORDINANCE APPROPRIATING FEDERAL GRANT (FUND 3761) - EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT (JAG) PROGRAM LOCAL SOLICITATION - FY 2021 **FUNDS FOR THE YEAR 2021."** 

WHEREAS, the County is eligible to receive a reimbursable federal Justice Assistance Grant (JAG) for the 2021-2022 grant year beginning October 1, 2021; and,

WHEREAS, this JAG Grant shall be up-fronted by County General; and,

WHEREAS, upon receipt and expiration of this grant, County General shall be reimbursed by the JAG Grant Fund 3761; and.

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF SALINE COUNTY. ARKANSAS:

Article 1. That Fund 3761 - JAG Grant FY 21-22 shall be established by the County Treasurer with Anticipated Revenues of \$15,054,00 for the year 2021.
