The Saline County Quorum Court met on Monday, December 20, 2021 at 6:30 p.m. in Courtroom #3 in the Saline County Courthouse. County Judge Jeff Arey called the meeting to order. Justice of the Peace Jim Whitley gave the invocation and Judge Arey led the Pledge of Allegiance.

Roll call was taken with 11 members present. Carlton Billingsley and Mark Grimmett were not in attendance.

Motion by Barbara Howell and seconded by Clint Chism to approve the Minutes from the November 15, 2021 Quorum Court Meeting. Motion passed by voice vote.

## **REPORTS**:

- 1. Presentation of Federal Audit; County Comptroller Angie Drummond handed out the report to the Quorum Court members and called their attention to the results. It was found that we had an 'Unqualified Opinion'. In accounting terminology that is a good result.

#### **APPROPRIATION ORDINANCE NO. 2022 - 1**

BE IT ENACTED BY THE QUORUM COURT OF SALINE COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

"AN ORDINANCE TO AMEND THE 2021 SALINE COUNTY BUDGET ORDINANCE NO. 2020-46; ANTICIPATE REVENUE AND TO APPROPRIATE/TRANSFER FUNDS THEREFORE TO THE VARIOUS BUDGETS; AND, FOR OTHER PURPOSES."

WHEREAS, the County received revenues in various funds which did not have anticipated revenue line items in the original budget for 2021 and need to be added as anticipated revenues in accordance with Ark. Code Ann. 14-20-103 (Article 1); and,

WHEREAS, the County Judge requests to transfer funds in the County General Fund, General Insurance various department budget line items to the Financial Management Department, General Insurance line item for insurance on the new CTE Center (Article 2); and,

**WHEREAS**, the County Judge requests to transfer funds in the CTE Center – Construction Fund from Capital Outlay-Construction to Small Equipment and General Supplies line items (Article 3); and,

WHEREAS, the Sheriff requests to transfer funds in the County General Fund, Sheriff Department from Telephone and Rent-Machinery & Equipment to Parts & Repairs line item (Article 4); and,

WHEREAS, the Coroner requests to transfer funds in the County General Fund, Coroner from Parts & Repairs to Part-Time Help and Retirement line items (Article 5); and,

WHEREAS, the County Judge requests to transfer funds in the County General Fund, OEM Department from Overtime to Salaries, Full-Time line items (Article 6); and,

WHEREAS, the State distributed funds above the County's appropriated budgeted amount in the 2021 year, the County Judge requests to appropriate funds in the Rescue Fund, Pay Out line item (Article 7); and,

WHEREAS, the Sheriff requests to transfer funds in the County Jail Fund, County Jail Department from Gap Hours and Health Insurance Match to Overtime, Certificate Pay, and Food line items (Article 8); and.

WHEREAS, the County Judge requests to transfer funds in the County Jail Fund, County Jail from Small Equipment, Parts & Repairs, Other Professional Services, and Waste Disposal to Maintenance & Service line item (Article 9); and,

WHEREAS, the Finance Committee previously met and approved this request.
