Invitation to Bid for **FEMA Drainage Mitigation at the Saline County Regional Airport**. The project bid will include mitigation of existing drainageways, channel excavation and filling, grouted rip-rap installation, and fence replacement, plus other incidental work items. Sealed bids must be in the office of the Saline County Airport Manager, no later than Monday, April 16, 2018 at 11:00 a.m., at which time all bids will be opened and read aloud.

Bidding documents may be obtained from the Saline County Regional Airport Manager during regular business hours, 8:00 a.m. – 4:30 p.m., Monday – Friday. Email requests shall be sent to <u>dane.pruitt@salinecounty.org</u>, and phone requests shall be made to 501-672-9809.

Successful bidders will receive a purchase order within 30 to 45 days after Airport Commission approval, if necessary.

Instruction to Bidders:

To be considered responsive, Bids must be made in accordance with the following instructions:

1. RECEIPT AND OPENING OF BIDS:

The Saline County Airport Commission (hereinafter called the "Owner") invites Bids on the Bid Form attached hereto, all blanks must be appropriately filled in. Bids will be received by the Owner at the Saline County Regional Airport, 1100 Hill Farm Road, Bryant, Arkansas, 72022 until 11:00 a.m. on Monday, April 16, 2018.

The Owner may consider informal any Bid not prepared and submitted in accordance with the provisions hereof and may waive any irregularities or reject any or all Bids. Bids received prior to the time of opening will be kept unopened. *Any Bid received after the time and date specified will not be considered.* No responsibility will be assumed by any person for the premature opening of a Bid not properly addressed and identified, such bids will be rejected.

2. PREPARATION OF BID:

Use Bid Form found herein. Bid prices are to be filled in ink or typewritten. The signature of the individual authorized to bind the Bidder shall be in longhand. Each bid must be submitted in a

sealed envelope bearing on the outside the name of Bidder, Bidder's contractor license number, address, and Bid Number for which bid is submitted, clearly written, and "**BID ENCLOSED**" noted on the envelope.

Pursuant to Arkansas Code Annotated Section 22-9-203, a certified check or bid bond in the amount of 5% of the total bid shall accompany bid.

3. CONDITIONS OF WORK:

Before submitting a Bid, Bidders shall carefully examine the General Conditions of the Contract, the Specifications under the Contract, visit the site(s) of the work, fully inform themselves as to all existing conditions and limitations, and shall include in the Bid the sums to cover the cost of <u>all</u> <u>items</u> included in the Contract, including all incidentals.

Insofar as possible the Contractor, in carrying out his work, must employ such methods or means as will not cause any interruption of, or interference with others. The bidder needs to include an anticipated delivery date (if applicable).

4. LAWS AND REGULATIONS:

The Bidder's attention is directed to the fact that all applicable State laws, county ordinances, and rules and regulations of all authorities have jurisdiction over construction of the project and shall apply to the Contract throughout and will be deemed to be included in the Contract the same as though written out in full.

5. OTHER:

It shall be understood by submission of Bid that Bidder agrees to the General Conditions as herein specified and if Bid is found to be acceptable to the Owner, the Bid Document will serve as a Contract Agreement with the Saline County Airport Commission.

Bid prices shall remain in effect for a period of sixty (60) days. The term of the Contract shall be from the date of the award and will run for one year from that date.

Upon the awarding of the Contract, a performance bond equaling the total amount of any bid must be provided.

BID SCHEDULE:

BIDDER agrees to perform all the work described in the CONTRACT DOCUMENTS for the below Lump Sum price.

TAXES: Saline County is NOT exempt from Arkansas State Sales and Use Taxes, or local option city/county sales taxes, when applicable, and bidders are RESPONSIBLE to the State Revenue Department for such taxes. ALL APPLICABLE TAXES SHALL BE INCLUDED IN THE BID. The total sales & use tax rate in the City of Benton is 9.0%.

GENERAL CONDITIONS:

PLEASE READ CAREFULLY

1. When submitting an "Invitation to Bid", the bidder warrants that the commodities covered by the bid shall be free from defects in material and workmanship under normal use and service. In addition, bidder must deliver new commodities of the latest design and model, unless otherwise specified in the "Invitation to Bid". 2. When bidding other than the brand and/or model specified in the "Invitation to Bid", the brand and/or model must be listed and descriptive literature attached to bid document.

3. Specifications furnished with this "Invitation to Bid" are intended to establish a desired quality or performance level, or other minimum dimensions and capacities, which will provide the best product available at the lowest possible price. Other than designated brands and/or models approved as equal to designated products shall receive equal consideration.

4. Samples of items when required, must be furnished free and, if not called for within 30 days from the date of the bid opening, will become the property of the Owner.

5. Prices quoted shall be "Free on Board" (F.O.B.) to destination at designated facility within Saline County. Charges may not be added after the bid is opened.

6. In the event a contract is entered into pursuant to the "Invitation to Bid", the bidder shall not discriminate against any qualified employee or applicant for employment because of race, sex, color, creed, national origin or ancestry. The bidder must include in any and all subcontracts, a provision similar to above.

7. All line items must be filled out or the bid will be opened, identified and declared a nonresponsive bid.

8. Quality, time and probability of performance may be factors in making an award.

9. Guarantees and warranties should be submitted with the bid, as they may be a consideration in making an award.

10. Any ambiguity in any bid as the result of omission, error, lack of clarity or noncompliance by the bidder with specification, instructions and all conditions of bidding shall be construed in the light most favorable to the Owner.

11. All terms and conditions stated herein shall constitute a complete and integrated document and the covenants contained herein shall not be altered or modified by paroled evidence unless such modifying term, conditions or covenants are in writing and are signed by the vendor and the agent of Owner.

12. CONSTRUCTION:

A. The Contractor is to supply the Owner with evidence of having and maintaining proper and complete insurance, specifically Worker's Compensation in accordance with the laws of the State of Arkansas, public liability and property damage. All premiums and costs shall be paid by the Contractor. In no way will the Owner be responsible in case of accident.

B. Pursuant to Arkansas Code Annotated Section 22-9-203, a certified check or bid bond in the amount of 5% of the total bid shall accompany bid.


C. When noted, a performance bond equaling the total amount of any bid must be provided for any contract for the repair, alteration or erection of any public building, public structure or public improvement.

13. Liquidated damages, when noted, shall be assessed beginning on the first day following the maximum delivery or completion time entered on the bid form and/or provided for by the plans and specifications.



Bidder agrees to this condition upon the signing of this document.


