EMERGENCY ORDINANCE NO. 2019-

BE IT ENACTED BY THE QUORUM COURT OF SALINE COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: "AN ORDINANCE AMENDING ORDINANCE NO. 2008-09 CREATING A PROPERTY CODE FOR HOT SPRINGS VILLAGE IN SALINE COUNTY, ARKANSAS."

WHEREAS, the Saline County Quorum Court in Ordinance No. 2008-09 created a property code for that area of Saline County, Arkansas known as Hot Springs Village, as authorized by A.C.A. § 14-14-814.

WHEREAS, the Board of Directors of the Hot Springs Village Property Owners' Association has, by formal action in writing, requested that Ordinance No. 2008-09 be amended.

NOW THEREFORE BE IT ORDAINED by the Quorum Court of Saline County, Arkansas that:

Article 1. Currently, Ordinance No. 2008-09 defines "Compliance Officer" as "means the Director of Planning and Inspections employed by the Hot Springs Village Property Owners' Association or designated employees of that Department."

Article 2. The term "Compliance Officer" shall be amended to read as follows:

Means an employee so assigned by the Hot Springs Village Property Owners' Association.

Article 3. EMERGENCY CLAUSE. This Ordinance being necessary to insure the public health, safety, and welfare insofar as they are affected by conditions and maintenance of structures and premises, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect upon and after its date of passage and publication.
