Unsigned bids will be rejected - no exceptions.**

Sealed bids for furnishing the commodities and/or services described below, subject to the Conditions attached hereto will be received at the above-noted mail and delivery locations until the above-noted bid opening date and time, and then publicly opened at the above-noted bid opening location. Bids must be submitted on this form, with attachments when appropriate, or bids will be rejected. Late bids and unsigned bids will not be considered.

**TERMS AND STANDARD CONDITIONS:**

By Submission of bid, bidder certifies that he/she has read all terms and conditions and that the bid is submitted in accordance therewith.

1. **ACCEPTANCE AND REJECTION:** Saline County reserves the right to reject any or all bids, to accept bids in whole or in part, to waive any informalities in bids received, to accept bids on materials or equipment with variations from specifications where efficiency of operation will not be impaired, and to award bids to best serve the interest of the County.
2. **PRICES:** Unless otherwise stated in the Bid Specifications, the following will apply: (1) unit prices shall be bid, (2) prices should be stated in units of quantity specified as (each), (3) prices must be F.O.B. destination specified in bid as 735 Neeley Street, Benton, Arkansas 72015 (4) prices must be firm and not subject to escalation.
3. **BID BONDS AND PERFORMANCE BONDS:** Bid Bond is not needed in invitation to bid. No Performance Bond is necessary.
4. **TAXES:** Saline County is not exempt from Arkansas State Sales and Use Taxes, or local option city/county sales taxes, when applicable, and bidders are responsible to the State Revenue Department for such taxes. ALL APPLICABLE TAXES SHALL BE INCLUDED IN THE BID. The total sales tax rate in the City of Benton is 9.375%.
5. **"ALL OR NONE" BIDS:** Bid shall be awarded on an all or none basis.
6. **SPECIFICATIONS:** Complete specifications should be attached for any substitution or alternate offered, or where amplification is necessary. Bidder's name must be placed on all attachments to the bid.
7. **EXCEPTIONS TO SPECIFICATIONS:** Any exceptions to the bid specifications must be stated in the bid. Any exceptions to manufacturer's published literature must be stated in the bid, or it will be assumed that bidder is bidding exactly as stated in the literature.
8. **BRAND NAME REFERENCES:** All brand name references in bid specifications refer to that commodity or its equivalent, unless otherwise stated in Bid Invitation. Bidder should state brand or trade name of items being bid, if such name exists.
9. **FREIGHT:** All freight charges should be included in bid price. Any change in common carrier rates authorized by the Interstate Commerce Commission will be adjusted if such change occurs after the bid opening date. Receipted common carrier bills that reflect ICC authorized rate changes must be furnished.
10. **SAMPLES AND LITERATURE:** Samples or technical literature must be provided within 14 days of request unless time is extended. Samples of items must be furnished free of charge, prior to or after the opening of bids, and, if not destroyed, will be returned upon request at the bidder's expense.
11. **GUARANTY:** Unless otherwise indicated in Bid Invitation, it is understood and agreed that any item offered or shipped on this bid shall be newly manufactured, latest model and design, and in first class condition; and that all containers shall be new, suitable for storage or shipment and in compliance with all applicable laws relating to construction, packaging, labeling and registration.
12. **BACKORDERS OR DELAY IN DELIVERY:** Failure to deliver within the time required will constitute default. The County has the right to extend delivery or not.
13. **NEGOTIATION:** All segments of the bid may be subject to negotiation.

14. WARRANTY: Bidder shall include in the bid the warranty.
15. AMBIGUITY: Any ambiguity in any bid as the result of omission, error, lack of clarity or noncompliance by the bidder with specification, instructions and all conditions of bidding shall be construed in the light most favorable to the County.
16. IDENTICAL BIDS: In the event of two or more identical low bids, Ark. Code Ann. § 14-22-111 shall apply.
17. SEALED BID: Place the bid in a sealed envelope and write the bid packet number (2022-11-21) on the outside of the envelope.
18. COSTS INCURRED BY PROPOSERS: All expenses involved with the preparation and submission of bids/proposals to the County, or any work performed in connection therewith, shall be borne solely by the Proposer(s). No payment will be made for any responses received, or for any other effort required of, or made by, the Proposer(s) prior to contract commencement.
19. CANCELLATION:
  - A. The County reserves the right to cancel this contract without cause by giving thirty (30) Days prior notice to the Contractor in writing of the intention to cancel or with cause if at any time the Contractor fails to fulfill or abide by any of the terms or conditions specified.
  - B. Failure of the contractor to comply with any of the provisions of the contract shall be considered a material breach of contract and shall be cause for immediate termination of the contract at the discretion of Saline County.
  - C. In addition to all other legal remedies available to Saline County, the County reserves the right to cancel and obtain from another source, any items and/or services which have not been delivered within the period of time from the date of order as determined by Saline County.
  - D. In the event sufficient budgeted funds are not available for a new fiscal period, the County shall notify the vendor of such occurrence and contract shall terminate of the last day of the current fiscal period without penalty of expense to the County.
22. ASSIGNMENT, SUBCONTRACTING, CORPORATE ACQUISITIONS AND/OR MERGERS:
  - A. The Contractor shall perform this contract. No assignment of subcontracting shall be allowed without prior written consent of the County. If a Proposer intends to subcontract a portion of this work, the Proposer shall disclose such intent in the bid proposal submitted as a result of this bid document.
  - B. In the event of a corporate acquisition and/or merger, the Contractor shall provide written notice to the County within thirty (30) calendar days of Contractor's notice of such action or upon the occurrence of said action, whichever occurs first. The right to terminate this contract, which shall not be unreasonably exercised by the County, shall include, but not limited to, instances in which a corporate acquisition and/or merger represent a conflict of interest or are contrary to any local, state, or federal laws. Action by the County awarding a proposal to a firm that has disclosed its intent to assign or subcontract in its response to the bid, without exception shall constitute approval for purpose of this Agreement.
23. NON-EXCLUSIVE CONTRACT: Award of this bid shall impose no obligation on the County to utilize the vendor for all work of this type, which may develop during the contract period. This is not an exclusive contract. The County specifically reserves the right to concurrently contract with other companies for similar work if it deems such an action to be in the County's best interest. In the case of multiple-term contracts, this provision shall apply separately to each item.
24. AWARDING OF CONTRACTS:

A. All Contracts shall be awarded to the lowest responsible bidder, taking into consideration all relevant facts, including without limitation quality, time of performance, probability of performance, and location

(1) Any bid may be rejected by the purchasing official

(2)

(a) Where bids are rejected, but the proposed purchase is not abandoned, and the circumstances indicate that further solicitation for bids would be to the best interest of the County, new bids may be called for.

(b) If the low bid is not accepted, a written statement shall be made by the purchasing agent and filed with the County Clerk giving reasons for such refusal.

C. All bidders shall be given equal consideration under the provisions of this chapter, except that when the bid represents items manufactured or grown in the county or offered for sale by business establishments having their principal place of business in the county with the quality being equal to articles offered by competitors outside the county, then the bidder shall be allowed a differential of not to exceed three percent (3%) of the purchase price in determining the low bid. However, in each instance in which this bid preference is requested, the bidder must so indicate before the date and time fixed for opening bids and thereafter furnish satisfactory proof if requested.

D. In all cases where there are equal or tie bids, preference shall be given to residents or firms located and doing business in the county.

#### 25. COMPREHENSIVE GENERAL LIABILITY

A. Including but not limited to bodily injury, property damage, and personal injury, with limits of not less than One Million Dollars (\$1,000,000.00) per occurrence, and annual aggregate.

B. Coverage shall be on "an occurrence basis" and the policy shall include broad form property damage coverage and contracted liability of not less than Two Million Dollars (\$2,000,000.00) aggregate, with Saline County as an additional insured;

#### 26. PROFESSIONAL LIABILITY INSURANCE

A. In an amount not less than One Million Dollars (\$1,000,000.00).

#### 27. WORKERS' COMPENSATION

A. Coverage and policy in compliance with the Arkansas Insurance Department with a minimum of One Million Dollars (\$1,000,000.00).

## **BID REQUIREMENTS**

- Successful bidder must be an "Authorized Distributor" of all specified products to insure delivery of products as well as warranty support. A letter from each manufacturer assuring "Authorized Distributor" status must accompany the bid submission.
- Successful bidder must employ "E.V.T. (Emergency Vehicle Technician) Certified Technicians to insure proper wiring of units.
- Successful bidder must warrant LABOR for installed products to match factory product warranty (i.e. any defective product must incur no charges to Saline County Sheriff's Office for repair / replacement / labor or otherwise)
- Successful bidder must provide current reference list (within the prior 12 months) of completed projects with equal or larger agencies.
- Require bidders to provide a statement of distributor capabilities, history, proof of financial stability with bid submission.
- Bidders must submit to a physical site inspection prior to bid award (if necessary) as well as before and during upfit process.
- Bidders must be able to guarantee production of 3 vehicles per week, until all vehicles are completed. (Once all equipment and vehicles are available.)

## **INSTALLATION INSTRUCTIONS**

- Installation will include the de-installation of radio, radar, modem, and watch-guard camera system to be installed in the new vehicle. All de-installed equipment will need to be installed with new wiring that meets all equipment manufacturer standards.
- Install company will be required to have training in Watchguard Installation to avoid any warranty issues with the Watchguard Camera System.
- All wired connections will be kept to only one on each wire and multiple connections off of one wire will not be allowed.
- All power wires will use at least 120% of the recommended wire size and not be under sized as specs require.
- All control boxes will be mounted by manufacturer standard in a way that ensures accessibility for future troubleshooting, and minimize risk of short circuiting.
- All wiring will be run in a clean and orderly fashion (utilizing looms and zip ties) to prevent accidental short circuiting.
- All hardware used for mounting on the exterior of the vehicle will be made of stainless steel to prevent rusting, and lock washers will be used.
- The install company must guarantee the work performed for 5 years and provide free labor to re-place any part that is under warranty that is purchased at the time of the install.
