TERMS AND STANDARD CONDITIONS

By submission of bid, bidder certifies that he/she has read all terms and conditions and that the bid is submitted in accordance therewith.

- 1. When submitting an "Invitation to Bid", the bidder warrants that the commodities covered by the bid shall be free from defects in material and workmanship under normal use and service.
- 2. The awarding of the bid will be by "Multiple Awards", which means the lowest price per zone to the lowest bidder. (Where the bid involves the furnishing of separate items or groups of items, the County reserves the right to make partial awards to different bidders for certain items or groups of items of the bid unless bidder qualifies his bid otherwise).
- 3. Sales or use tax is not to be shown in bid price but is to be added by the vendor to the invoice billing to the County. The County is not exempt from Arkansas Sales and Use Tax. Vendors are to register and pay tax directly to the Arkansas Department of Finance and Administration.
- 4. Discounts offered will be taken when the County qualifies for such. The beginning date for computing discounts will be the date of the invoice, or the date of delivery and acceptance, whichever is later.

- 5. When bidding other than the brand and/or model specified in the "Invitation to Bid", the brand and/or model must be listed and descriptive literature attached to bid document.
- 6. Identical Bids: In the event of two or more identical low bids, Ark. Code Ann. § 14-22-111 shall apply.
- 7. Specifications furnished with this "Bid Packet" are intended to establish a desired quality or performance level, or other minimum dimensions and capacities, which will provide the best product available at the lowest possible price. Other than designated brands and/or models approved as equal to designated products shall receive equal consideration.
- 8. Samples of items when required must be furnished free and, if not called for within 30 days from the date of the bid opening, will become the property of Saline County.
- 9. Prices quoted shall be "Free on Board" (F.O.B.) to destination at designated facility within Saline County, unless otherwise specified.
- 10. In the event a contract is entered into pursuant to the "Bid Packet", the bidder shall not discriminate against any qualified employee or applicant for employment because of race, sex, color, creed, national origin or ancestry. The bidder must include in any and all subcontracts, a provision similar to above.
- 11. The Saline County Judge reserves the right to award items, all or none, or by line item(s).
- 12. Quality, time and probability of performance may be factors in making an award.
- 13. Guarantees and warranties should be submitted with the bid, as they may be a consideration in making an award.
- 14. Any ambiguity in any bid as the result of omission, error, lack of clarity or noncompliance by the bidder with specification, instructions and all considerations of bidding shall be construed in the light most favorable to the County.
- 15. After bidding this job, place the bid in a sealed envelope with company information and write the **Bid Number 2023-03-21** on the outside of the envelope.
- 16. All terms and conditions stated herein shall constitute a complete and integrated document and the covenants contained herein shall not be altered or modified by parol evidence unless such modifying term, conditions or covenants are in writing and are signed by the vendor and the agent of Saline County.
- 17. CONSTRUCTION:
 - A. The Contractor is to supply Saline County with evidence of having and maintaining proper and complete insurance, specifically Worker's Compensation in accordance with the laws of the State of Arkansas, public liability and property damage. The Contractor shall pay all premiums and costs. In no way with the County be responsible in case of an accident or property damage.
 - B. No bid bond or certified check in the amount of 5% is required.
 - C. The Quorum Court passed Resolution No. 2006-10 which states all contracts entered by Saline County shall contain language requiring the contractor to abide by all federal, state and local laws, which do apply to OSHA regulations.
- 18. Liquidated damage in the amount of \$300 per day shall be assessed beginning on the first day following the 45-day completion time. Written notice to proceed will be the official start date of the project; the project shall be completed within 45 calendar days.
- 19. Whenever a bid is sought seeking a source of supply for a specified project for materials and/or services, the quantities of usage shown is estimated ONLY. No guarantee or warranty is given or implied by the participants as to the total amount that may or may not be purchased from any resulting contracts. These quantities are for the bidders' information ONLY and will be used for tabulation and presentation of the bid and the participant reserves the right to increase or decrease quantities as required. Bidder agrees to this condition upon the signing of the document.
- 20. Saline County reserves the right to reject any and all bids, to accept in whole or in part, to waive any informalities or technicalities in bids received, to accept bids on materials or equipment with variations from specifications in those cases where efficiency of operation will not be impaired and unless otherwise specified by the bidder, to accept any item in the bid. If unit prices and extensions thereof do not coincide, Saline County may accept the bid for the lesser amount whether reflected by the extension or by the correct multiple of the unit price.

SPECIFICATIONS

It shall be understood by submission of bid that bidder agrees to the "Conditions" as herein specified and if the bid is found to be acceptable to Saline County, this bid document will serve as a contract agreement with Saline County.

- The bid shall specify the price per ton for paving various roads. Bid shall include cost of asphalt and paving.
- All specifications shall conform to current AHTD Standard Specification for road construction.
- Saline County will direct where the work is to be performed.
- The contractor will be responsible for mobilization of men and necessary equipment.
- The contractor will provide the asphalt, labor and equipment for the paving application.
- Bid shall be based on per-ton by zone.
- By submitting this bid, bidder acknowledges that Saline County and all municipalities in the County are local public procurement units. If accepted, this bid will be considered a cooperative purchasing agreement as defined in Ark. Code Ann. § 19-11-249 and successful bidder agrees to furnish the commodities bid upon to all local units who elected to participate in the bid agreement. Local units who may participate in bid agreement may include but not be limited to Saline County, City of Benton, City of Bryant, City of Shannon Hills, City of Haskell, City of Traskwood, City of Alexander, and the City of Bauxite.

ASPHALT APPLICATION

- 1. A three-inch (3") HMAC Overlay (HMAC primed or tacked in place) is required for Saline County roads.
- 2. Construction/application shall conform to the latest edition AHTD specifications.
- 3. All driveways shall have a minimum (2') turnout and all County Roads shall have a minimum (20')
- 4. In case of default of contractor in making deliveries as per contract, the County may procure the articles or services from other sources and hold the contractor responsible for all excess costs occasioned thereby. Bidder's record as to satisfactory performance under previous contracts will be considered a factor in making awards and retention on bid lists.
- 5. Contractor will be responsible for hauling asphalt to the worksite.
- 6. Work will be completed within 45 days of notification.
- 7. The contractor will provide safety personnel for flagging all work on Saline County roads.
- 8. Bidders must be able to demonstrate a minimum of one year of successful history in Saline County or a similarly situated jurisdiction for asphalt paving road projects that have been constructed, supervised or observed by road department officials.
- 9. Final inspections and acceptance or rejection will be made after delivery. Items rejected because of nonconformance shall be removed and replaced immediately with those which meet specifications, all at the expense of the contractor. In the event that necessity requires the use of non-conforming items, payment therefore will be made at a proper reduction in price which shall be not greater than contractor's actual cost by purchase, fabrication, manufacture or other production method plus transportation paid to carriers. All costs in connection with the testing items that do not meet specifications shall be paid by the contractor.
- 10. The County reserves the right to change any specifications, terms and/or conditions at any time, with adequate notice in writing to bid invitees of those changes, if any.
