SALINE COUNTY QUORUM COURT MINUTES APRIL 15, 2024

The Saline County Quorum Court met on Monday, April 15, 2024 at 6:30 p.m. in Courtroom #3 at the Saline County Courthouse. County Judge Matt Brumley called the meeting to order. Justice of the Peace Jim Whitley gave the invocation and Justice of the Peace Clint Chism led the Pledge of Allegiance.

Roll call was taken with all members in attendance.

Motion by Rick Bellinger and seconded by Barbara Howell to approve the Minutes from the March 18, 2024 Quorum Court Meeting. Motion passed unanimously by voice vote.

REPORTS/PROCLAMATIONS:

A copy of the Prosecuting Attorney's Hot Check Report was given out to the members.

A Proclamation was presented by Judge Brumley declaring April 14th through April 20th Public Safety Telecommunications Week.

Additionally, Elly Stone, Intern from Arkansas Tech, was presented an honor by Jerry Cohen, Director and Stuart Duke, Deputy Director of OEM for all of her hard work and efforts during her time with Saline County.

BE IT ENACTED BY THE QUORUM COURT OF SALINE COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: "AN ORDINANCE PROVIDING FOR CERTIFICATE PAY FOR SALINE COUNTY SHERIFF'S OFFICE DEPUTIES BASED ON THEIR CURRENT ARKANSAS COMMISSION ON LAW ENFORCEMENT STANDARDS AND TRAINING PROFESSIONAL CERTIFICATES."

WHEREAS, Ark. Code Ann. § 14-14-801, as provided by Arkansas Constitution, Amendment 55, § 1, Part (a), states that a county quorum court may fix the number and compensation of deputies and county employees; and

WHEREAS, the Arkansas Commission on Law Enforcement Standards and Training has established minimum standards for the training of law enforcement officers and a Saline County Sheriff's Office Deputy must possess a Basic certification to be employed as a Deputy at the Saline County Sheriff's Office; and

WHEREAS, the Arkansas Commission on Law Enforcement Standards and Training also provides for General, Intermediate, Advanced, and Senior Training Certificates; and

WHEREAS, the Quorum Court of Saline County desires to compensate Saline County Sheriff's Office Deputies for obtaining Training Certificates.

NOW THEREFORE BE IT ORDAINDED by the Quorum Court of Saline County, Arkansas that:

<u>Article 1.</u> In addition to annual pay, Saline County Sheriff's Office ("SCSO") Deputies shall receive additional compensation ("certificate pay") based on their current Arkansas Commission on Law Enforcement Standards and Training ("CLEST") Certificates.

Article 2. SCSO Deputies shall receive certificate pay if they possess a General Certificate or higher and they have been employed by the SCSO for at least 12 consecutive months. CLEST-certified SCSO personnel who possess or acquire a General Certificate or higher shall receive certificate pay based on their hire date or the date the certificate was awarded. Certificate pay shall be prorated in the calendar year in which the personnel became eligible, based on the date upon which the employee was awarded an eligible certificate or upon the hire date if the employee held an eligible certificate upon being hired.

Article 3. The amount of certificate pay that a SCSO Deputy shall receive shall be based on the following:

General Certificate: \$125 per month

Intermediate Certificate: \$175 per month

Advanced Certificate: \$200 per month

Senior Certificate: \$250 per month

<u>Article 4.</u> If an employee with prior Arkansas law enforcement experience is hired and possesses certificate(s), it will be at the discretion of the Saline County Sheriff whether that employee receives any pro-rated certificate pay between six and twelve months.

<u>Article 5. Article 4.</u> Certificate pay will be paid in a one-time, lump sum at the first pay period in December of each calendar year.

If an employee is terminated or resigns for any reason prior to the 23rd pay period, the employee will receive prorated compensation for certificate pay for the time served during that given year. If an employee is terminated or resigns for any reason prior to the 23rd pay period, the employee shall not receive certificate pay for the time served during that given year. This article shall not apply to authorized retirements.

It is the responsibility of each SCSO Deputy to present his/her his or her certificates to the SCSO Training Officer and the Saline County Human Resources Office prior to November 1st of each calendar year.

It is the responsibility of each SCSO Deputy to ensure their proper certificates are in their respective files. If there is not an actual certificate on file, the SCSO deputy will not be compensated.

<u>Article 5.</u> Severability – Should any word, phrase, or section of this ordinance be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity shall not affect the force and validity of the remaining portion of sections of this ordinance.

<u>Article 6.</u> Retroactive Applicability – This Ordinance shall apply retroactively and be considered effective as of January 1, 2024.

WHEREAS, the need for equipment to be housed at the Detention Center to be used for the testing of DNA to assist in investigations by the Sheriff's Department; and

WHEREAS, the need to conduct investigations with the most accuracy, in order to provide the best data as possible to assist the Saline County Sheriff's Office on delivering the best information for courts and to close cases, and

WHEREAS, the funding requested through the Byrne Discretionary Grants Program/Rapid DNA System Pilot Program for Investigations — FY 2024-2028 will provide \$1,000,000.00 to address these needs, and matching funds are not required; and

WHEREAS, the members of the Saline County Quorum Court have had an opportunity to review and comment on the contents of the Byrne Discretionary Grants Program/Rapid DNA System Pilot Program for Investigations – FY 2024-2028 grant application; and

WHEREAS, the Saline County Quorum Court assures the United States Department of Justice, Office of Justice Programs, Bureau of Justice Assistance that the application or any future amendments have been or will be made public and an opportunity to comment has been or will be provided to citizens.

NOW, THEREFORE, BE IT RESOLVED that the Saline County Quorum Court hereby authorizes and directs the Saline County Grants Administrator to submit the Byrne Discretionary Grants Program/Rapid DNA System Pilot Program for Investigations – FY 2024-2028 grant application.

APPROPRIATION ORDINANCE NO. 2024 - _____

BE IT ENACTED BY THE QUORUM COURT OF SALINE COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

"AN ORDINANCE TO AMEND THE 2024 SALINE COUNTY BUDGET ORDINANCE NO. 2023-30; ANTICIPATE REVENUE AND TO APPROPRIATE/TRANSFER FUNDS THEREFORE TO THE VARIOUS BUDGETS; AND, FOR OTHER PURPOSES."

WHEREAS, the County previously appropriated funds in the 2023 budget for the purchase of a combiner to be used in the 911 Plan to consolidate the City of Bryant into the Saline County Emergency Center in the 2024 year, but the combiner was delayed in shipment and the 2023 financial year was closed prior to that shipment; and in the consolidation, the City of Benton, the City of Bryant, and the County share the costs of the combiner and other added expenses due the consolidation, with the City of Bryant contributing 50% of the cost by vote of the Board (Article 1); and, the 911 Department requests to appropriate funds in Fund 3020 – 911 Emergency Fund for the payment of this invoice; and

WHEREAS, the Sheriff's Office has one current administration vehicle that is going to cost several thousand to repair or trade on another replacement vehicle, which they have found in accordance with state contract; and the County has sold many of the prior fleet through auction, and the funds have been deposited into the County General Fund; and the Sheriff requests to use a portion of these funds to replace this needed vehicle and appropriate funds in Fund 1000 – County General Fund, 0400 – Sheriff Department budget (Article 2); and,

WHEREAS, the Public Defender's Office has several employees going to conferences; and the Public Defender requests to transfer funds to travel from small equipment and part-time help line items in Fund 3024 – Public Defender's Fund (Article 3); and,

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF SALINE COUNTY, ARKANSAS:

<u>Article 1.</u> That the sum of \$58,894.57 is hereby appropriated and anticipated revenues increased in Fund 3020 – 911 Emergency Fund budget as follows:

"AN ORDINANCE APPROPRIATING FUNDS RECEIVED FROM THE STATE BOARD OF ELECTION COMMISSIONERS OFFICE FOR SUPPLEMENTAL STIPEND TO ELECTION WORKERS FOR THE YEAR 2024."

WHEREAS, the County Clerk received checks from the Arkansas State Board of Election Commissioners ("State Board") as reimbursement for election workers attending required election trainings and the County Clerk Office Manager/Election Coordinator for attending required election coordinator training; and,

WHEREAS, the County compensates election workers, and also the County Clerk Office Manager/Election Coordinator, for performing such duties; and,

WHEREAS, the County Clerk requests to appropriate these funds received from the State Board to pay an additional stipend/bonus to the County Clerk Office Manager/Election Coordinator, other employees in the County Clerk's office, and Election Commissioners; and,

WHEREAS, the County will be responsible for FICA and APERS employer portion for these stipends/bonuses to the employees; and,

WHEREAS, the Finance Committee previously met and approved this request.

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF SALINE COUNTY, ARKANSAS:

<u>Article 1</u>. That Fund 1000 – County General Fund shall be increased by the County Treasurer with additional Anticipated Revenues of \$1,524.96 for the year 2024.

EMERGENCY ORDINANCE NO. 2024 - ____

BE IT ORDAINED BY THE QUORUM COURT OF SALINE COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: AN ORDINANCE TO ESTABLISH A SUB-FUND OF COUNTY GENERAL TO BE CALLED THE DISASTER RELIEF FUND AND APPROPRIATE FUNDS TO THE DISASTER RELIEF FUND BUDGET; AND TO DECLARE AN EMERGENCY.

Article 1. Affirmation. It comes before this Court that there is a need to establish a fund on the books of the county as a sub fund of the County General Fund No. 1000 to track the revenues, expenditures and/or appropriated transfers of disaster assistance through funds received through reimbursement for payroll paid from the County General Fund through the CARES Act as received by the county from the State of Arkansas. This Court recognizes and affirms the need for such a fund to properly account for and control all such revenues received and expenditures made in compliance with all applicable laws.

<u>Article 2. Establishment of Fund</u>. There is hereby created on the books of the Saline County Treasurer and the books of the Saline Comptroller a fund to be known as the Disaster Relief Fund with a fund number of <u>1008</u> as assigned by the Saline County Quorum Court.

Article 3. Operation of Fund. The Disaster Relief Fund is subject to all the normal county budgeting, appropriation and expenditure regulations of Arkansas Code Annotated, Title 14 and the County Financial Management System. As a sub fund of the County General Fund any balance in the fund is considered accruable to County General and is part of the general fund balance in aggregate as defined in A.C.A. 14-15-805(3). Any revenue received shall be used for the purpose to exclusively relieve a portion of Saline County from expenses related to a disaster approved as a county project. Any revenue is unrestricted county revenue and may be expended for any legal county expense.

Article 4. Appropriation of Funds. The sum of \$500,000.00 is hereby appropriated and anticipated revenues increased in Fund 1008 – Disaster Relief Fund and the sum of \$500,000.00 is hereby appropriated and anticipated revenues increased in Fund 1005 – Federal Coronavirus Relief Fund budget as follows:

<u>Article 5. Emergency Clause</u>. It is found by this Court that a sub fund of County General be established in order to be able to properly track the revenue, appropriated expenditures and/or appropriated transfers for the Disaster Relief Fund. Therefore, an emergency is declared to exist and this ordinance shall be in full force and effect from the date of passage and approval.
